HOW DOES ICC AFGHANISTAN MEMBERSHIP WORK FOR YOU?

Since ICC Afghanistan represents ICC, the world business organization in Afghanistan and facilitates the active participation of members in the general activities of ICC, its members would have the following benefits and advantages:

1. Participate in the work of ICC's commissions and special working groups. ICC Commissions comprised of business experts from around the world who regularly meet to scrutinize proposed international and government initiatives affecting their subject areas;
2. Have access to business-critical information on international policy and regulatory issues. Information to be gained include summary records of commission meetings, fact sheets summarizing particular subjects, statements, materials circulated for comments (draft rules, codes, recommendations to governments, etc.);
3. ICC's privileged links with major international organizations, including the UN and its specialized agencies and the World Trade Organization, allow the ICC to effectively represent the interests of its members in international forums. ICC members prepare business position for submission to international organizations and also, through ICC's global network of national committees, to governments worldwide;
4. ICC Afghanistan offers to members many of the advantages of belonging to a prestigious club and the chance to forge business relationships at the highest level at exclusive ICC events. By being part of ICC, members gain influence both at national and international level;
5. All members of ICC Afghanistan are automatically members of the International Chamber of Commerce, the world business organization (ICCWBO).



WHO CAN BECOME A MEMBER OF ICC AFGHANISTAN?

1. All companies, corporation and partnerships, individual businessperson with a valid business license involved in international business activities or investment, whether private, collective, public or state-owned and including foreign-owned entities.
2. Chambers of Commerce and industry, nonprofit organizations, nongovernment organizations, business, membership organizations, business councils, professional associations, unions and cooperatives, weather local, provincial, regional and national, including joint and bilateral chambers representing foreign business in Afghanistan>
3. Scholars, academics, professionals and individuals who are theatrically involved in international business.
4. Non-voting honorary membership may be conferred to individuals who have made outstanding contributions to the work of ICC Afghanistan and Afghanistan business and economic sector Honorary members shall be exempt from fees.

MEMBERSHIP CATEGORIES AND DURATION

General, there are 5 main categories of ICC Afghanistan membership which are as follows:

Main Membership Category	Sub-category Membership
